

# Terms of Use

## **Introduction; Consent to Terms**

Please read these Terms of Use before using the World Wide Web site of NPR Listens, currently located at the [www.nprlistens.org](http://www.nprlistens.org) domain and subdomains, or any features of this site (collectively the "Site"). National Public Radio, Inc. ("NPR") is making the Site available to you under these Terms of Use. By using the Site in any way, including merely browsing, you agree to be bound by the Terms of Use. If you do not agree to be bound by the Terms of Use, please exit the Site. NPR reserves the right, in its discretion, to modify, add, or delete portions of the Terms of Use at any time without notice to you by posting updated Terms of Use on the Site. Please check the Terms of Use frequently for updates. Any modifications, additions, or deletions shall be effective immediately on posting of updated Terms of Use. Your continued use of the Site following the posting of updated Terms of Use will mean that you agree to those changes.
